#### CIUTAT DE PALMA AWARD SHORT DOCUMENTARIES 2014

#### Award

- **1.** The Ciutat de Palma Award for Short Documentaries 2014 is awarded with 5,000 euros.
- 2. There is only a unique and indivisible prize. This award is governed by the principles of advertising and competitive concurrency.

# **Participation**

- **3.** Spanish or foreign nationalities residing in Spain candidates, may participate with fictional short films produced during the period commencing 1<sup>st</sup> November 2013 until 29<sup>th</sup> August 2014.
- **4.** Candidates can submit up to a maximum of 2 documentaries.
- **5.** Total running time for each film must be 30 minutes or less, including titles and credits.

There shall be excluded from this competition:

- Short films created for advertising or commercial purposes
- Partial montages from feature films
- Television episodes, including pilots of series or assembly from them
- **6.** The participants authorize, by registering, all promotional activities involving the total o partial projection, nonprofit, of the short film submitted to the contest, in cultural events promoted by the Palma de Mallorca City Council and other events related to this award, as well as the authorization of frames of works presented.
- **7.** The Palma de Mallorca City Council is not responsible for the use of images and music works on which there are restrictions such a copyright or intellectual property rights.
- **8.** The Council reserves the right to edit a DVD or a Blu-ray including the prizewinning works, for artistic and cultural purposes only.
- **9.** All Content that spread racist messages and/or xenophobic, pornographic or which infringe the Fundamental Rights of individuals will be rejected.

### Format and submission of Short Documentaries

- 10. No purchase required
- 11. Contents can be submitted in any language but those works different from Spanish or Catalan must be subtitled in one of these 2 languages.

- **12.** All the information about how to enter the Competition and how to send films, on the Palma City Council website <a href="https://www.cultura.palma.es">www.cultura.palma.es</a>.
- **13.** Deadline to submit films ends on August 29, 2014.
- **14.** The Organization will automatically reject the works which do not obey requirements and deadlines.

## Jury

- **16.** A selection committee, composed of professionals and/or artists within audiovisual media, will select the finalists from among all submitted. Finalists will be released from the 1<sup>st</sup> of December onwards.
- **17.** The Jury will consist of a maximum of 5 members (recognized professionals within the film industry, audiovisual sector and culture).
- **18.** Jury verdict will be final and the Award can be declared void if they consider to, motivating that resolution. An Honorable mention can also be given if appropriate.

## **Award Ceremony**

- 19. The Award will be delivered during the "Saint Sebastian festivities 2015".
- **20.** Winner/s must be present at the Awards Ceremony. The Palma City Council is not responsible for the cost of presence.

# Tax legislation

- **21.** The prize will be subject to the tax laws in force.
- **22.** The prize-winner shall provide the following documentation:
  - a. Certificate issued by the *Tesoreria General de la Seguridad Social* demonstrating compliance with the social security obligations.
  - b. Certificate issued by the *Agencia Estatal de Administración Tributaria*, demonstrating compliance with the taxation laws.
  - c. A Responsible statement verifying that the winner is not affected by any of the prohibitions as established in sections 2 and 3, art. 13. Law 38/2003, November 17th of General Subsidies.
  - d. Winners without residence in Spain, certificate issued by the Competent Tax Authority, from the country concerned, certifying tax residence.

# Acceptance and interpretation of all Terms and Conditions

- **23.** Participating in the Prize implies the acceptance of all terms and conditions.
- **24.** The jury has the power to interpret them and to fill any gaps or voids in accordance with its intended purpose.
- **25.** The Council will solve any problem not foreseen in these terms and conditions.
