## CIUTAT DE PALMA ANTONI GELABERT VISUAL ARTS AWARD 2013

- 1. The Ciutat de Palma Antoni Gelabert Visual Arts Award 2013 awards a prize of 12,000 € for the winning work.. Moreover, the Fundació Palma Espai d'Art will afford the production costs of an exhibition project of the winning artist for a maximum amount of 3,000 €. This exhibition project will be presented in Casal Solleric on January 20th 2015, after it has been approved by the Executive Commission of the Fundació Palma Espai d'Art.
- 2. The prize is indivisible and the jury can declare void if motivated. Their decision is final
- 3. The Ciutat de Palma Award for Visual Arts will be announced in the event of the Ciutat de Palma Awards, during the Sant Sebastià festivities of 2014.
- 4. The winner shall be obliged to transfer ownership of the prize-winning work to Palma City Council, together with corresponding material and intellectual property rights and the right to its publication, exhibition, reproduction, etc. The jury will take into account both the artist's career and the assessment of the winning work.
- 5. The prize-winning work will become part of the municipal contemporary art collection.
- 6. The Award is open to artists of any nationality and residence.
- 7. Dossiers shall be submitted in digital format (a hard copy version may also be submitted) and they shall include:
  - a. Academic and professional resume with the artist's full name, NIF, address, e-mail address and phone number.
  - b. A body of work, not to exceed three unpublished and original works with corresponding captions. The subject of the works vying for this prize is open, and any technique may be used.
  - c. Photographs of other pieces and exhibitions from recent years with corresponding captions.
  - d. Catalogs from recent exhibits, if they have.
  - e. Copies of any appropriate bibliographies and reviews.
- 8. Dossiers will be accepted via e-mail and also from Monday to Friday, from 10 am to 2 pm, between September 16th and October 31st 2013, at the la Fundació Palma Espai d'Art headquarters in Casal Solleric (passeig del Born, 27; 07012 Palma; phone nr. 971722092; e-mail: <a href="mailto:solleric@palma.es">solleric@palma.es</a>). Dossiers shall be submitted or delivered labelled with the indication PREMI CIUTAT DE PALMA ANTONI GELABERT D'ARTS VISUALS 2013.

Artists or their representatives will be given a receipt upon submission of their dossier. Dossiers can also be sent by mail or messenger –postage and packing paid– to the aforementioned address. Dossiers sent by mail, postage paid, will be accepted only if postmarked on or before October 31st. Once the panel of judges has made their decision, materials will be returned at the express request and expense of the artist.

- 9. The jury, which will be chosen by the Mayor of Palma, will be announced before the submission deadline.
- 10. The jury, based on the dossiers submitted of the artists' body of work, will select pieces to participate in an exhibit during the Sant Sebastià festivities of 2014.
- 11. Artists must submit the selected pieces by a deadline to be established by the curator of the exhibit, which will be at least fifteen days before the inauguration of the exhibition. Artists shall be obliged to transfer copyrights and photographic reproduction rights to Palma City Council. Palma City Council will assume all transportation costs for the selected works, except for the winning one, up to 300 € per work. Works selected as finalists will be no more than twenty. (Corresponding receipts must be submitted to Fundació Palma Espai d'Art no later than 15 days after the work has been returned to its owner.)
- 12. Fundació Palma Espai d'Art will count a team of professionals and its usual resources to set up the exhibition of the finalists and the winner. Any special needs must be provided by the artist (audiovisuals, computers, lightning or any other).
- 13. Appropriate measures will be taken to safeguard and conserve the selected work; however, Palma City Council will not be responsible for any wear and tear or accidents that may occur while the pieces are in its custody.
- 14. Artists selected to participate in the exhibition will have no more than two months from the exhibition's closing to reclaim their work or to arrange for its transport. Palma City Council will not be held responsible for works not claimed after this date and may freely dispose of such works.
- 15. The award shall be subject to the tax legislation in force. The prize-winner shall provide the following documentation:
  - a certificate issued by the *Tesorería General de la Seguridad Social* demonstrating that he keeps up to date with his Social Security obligations.
  - a certificate issued by the *Agencia Estatal de Administración Tributaria* demonstrating that he keeps up to date regarding his tax obligations.
  - a responsible statement verifying that he is not affected by any of the prohibitions established at the paragraphs 2 and 3 of section 13 of the Law 38/2003, of November 17th, General of Subsidies.
  - if his residence for tax purposes is not in Spain, he will have to produce a certificate issued by the competent tax authority in the corresponding country, certifying his residence for tax purposes.
- 16. Participation in the Ciutat de Palma Antoni Gelabert Visual Arts Award 2013 implies full acceptance of these rules. The prize jury has the power to interpret them and fill any gaps or voids in accordance with its intended purpose.
