# CIUTAT DE PALMA AWARD FOR FICTION SHORT FILMS AND DOCUMENTARIES 2013

The Ciutat de Palma Award for Fiction Short Films and Documentaries 2013 fall under the following categories:

- Best fiction short film. It awards a price of 5,000 €
- Best short documentary film. It awards a price of 5,000 €

#### 1. Entries

Candidates are producers of Spanish or foreign nationalities residing in Spain, whose fiction short films and/or documentaries have been created between November 1st 2012 and October 31st 2013. Short films should have a total running time no longer than 30 minutes, including front and back credits.

The following projects shall be excluded of the present call:

- short films created for advertising or commercial purposes
- partial montages of feature-films
- tv episodes, including pilots of series or montages of them

### 2. Participation

Participating in the Ciutat de Palma Award for Fiction Short Films and Documentaries 2013 is free and the works must be submitted **before November 1st 2013.** 

Those works for languages other than Spanish or Catalan must be subtitled in one of these two languages. Each candidate may submit a maximum of 2 works.

Each work will contain the following documentation:

- entry form
- synopsis (3 lines maximum)
- bio-filmography of the director/s (5 les maximum)
- photocopy of DNI or identity card
- 3 images of the short film in digital format (JPEG, Targa, TIFF)
- 1 recent photograph of the director/s in digital format JPEG

### 3. Formats

Short films should be presented in data DVD or a pen drive, including a digital file of the short film (MOV, AVI or MP4), with a minimum resolution of 1.280 x 720, preferably in full HD (1080 p). If more than one short film is submitted by the same person or institution, the material can be sent on a single DVD, but an entry form must be filled out for each competing work. The works should be correctly labelled with the author or authors' name and data.

# 4. Shipping

Shipping and handling for participating in the Award are on participants' account. The Palma City Council is not responsible for any damage resulting from the submission. The works together with the documentation should be sent the following address:

Palma City Council will automatically reject those works that do not meet these requirements.

## 5. Spreading

The short films participating in the Award will be part of the video and film library of Palma City Council, and they may be exhibited, with no commercial purposes, as audiovisual material in artistic-cultural events promoted by Palma City Council and in events related to the Ciutat de Palma Award for Fiction Short Films and Documentaries. Furthermore, Palma City Council shall use stills of participating films in order to promote the Award. Palma City Council also reserves the right to release a DVD or Blu-ray including the awarded works, only with artistic and cultural purposes.

#### 6. Selection

A committee of selection composed by professionals and artists within the audiovisual world will be in charge of short-listing and selecting finalist works. Finalist short films will be announced from December 15<sup>th</sup> 2013 onwards.

# 7. Jury

The Jury of the The Ciutat de Palma Award for Short Films 2013 will consist of professionals within the audiovisual and cultural fields. The decisions of the committee and the Jury will then be indisputable.

#### 8. Prize award

Regardless of the date of the winners' public announcement, the Ciutat de Palma Award for Fiction Short Films and Documentaries 2013 will be given during the Saint Sebastian festivities of 2014.

**9.** Palma City Council is not responsible for the use in the works of images and music on which there are restrictions of authorship and intellectual property.

**10.** The award shall be subject to the tax legislation in force. The prize-winner shall provide the following documentation:

- a certificate issued by the *Tesorería General de la Seguridad Social* demonstrating that he keeps up to date with his Social Security obligations.
- a certificate issued by the *Agencia Estatal de Administración Tributaria* demonstrating that he keeps up to date regarding his tax obligations.
- a responsible statement verifying that he is not affected by any of the prohibitions established at the paragraphs 2 and 3 of section 13 of the Law 38/2003, of November 17th, General of Subsidies.
- if his residence for tax purposes is not in Spain, he will have to produce a certificate issued by the competent tax authority in the corresponding country, certifying his residence for tax purposes.

# 11. Acceptance of rules

Participation in the Ciutat de Palma Award for Fiction Short Films and Documentaries 2013 implies full acceptance of these rules. Palma City Council will solve any issue not anticipated in them.
